

AMENDMENT OF RULES

1. Neethling Family here in after referred to as "THE Management", would bring the following specific terms and conditions to your attention. Management reserves the right to amend the terms and conditions without prior notice, in their absolute discretion for use of EIKEBOS CAMPSITE.

2. RIGHT OF ACCESS

Management reserves the right of access to any person or institution without disclosing any reason. They will further be entitled to evict any person who does not comply with the rules, or who disturbs the peace, or violates the rights of other visitors, or who performs any act that may be construed as undermining the peace and tranquility of the camp, and more in particular with reference to, but not necessarily limited thereto:

2.1 noncompliance with number of persons and/or vehicles, which shall be limited

Four (4) persons per campsite (7 campsites), one (1) vehicle and (1) caravan/ tent, or a single tent or 1 bush wagon per site.

In the event of more than 28 persons occupying the campsite, an additional amount per night per person shall be charged, subject to a maximum of 36 persons in the campsite;

Extra tent(s) and vehicle(s) will only be allowed with prior agreement and permission of the management.

2.2 no disorderly behavior will be permitted or tolerated, and in the event of visitors committing such behavior, management will be entitled to evict them and/or request that they vacate the campsite

2.3 the premises may not be used for any unlawful activity, nor may visitors do not permit persons who commit such activities to occupy the site, nor may they permit the campsite to be accommodated by more than the limited number of persons;

2.4 visitors shall leave the campsite in a clean and orderly manner, and remove all rubble and refuse to a location provided for and no littering of cigarette butts in campsite

2.5 no visitor shall violate any of the campsite rules;

2.6 no visitor shall fail to report as visitor or enter the premises without payment or in conflict with the rules or use for any other purpose than its object of being a camping site;

2.7 visitors shall comply with all legislation regarding public smoking and not permit any pets on the premises

2.8 no visitor shall abuse or be under the influence of alcohol or other narcotic substance;

3. TARIFFS AND RESERVATION

No Reservation shall be valid and/or enforceable unless:

3.1 The reservation form has not been completed;

3.2 it has been provided to the management by e-mail or fax

3.3 management has not received it;

3.4 management has not received the required deposit and pre-paid amounts have been made;

3.5 a telephonic conformation, or by e-mail or fax has been received by the visitor;

4. PAYMENT

50% of the amount due for the entire period of reservation is payable as deposit on or before the return date, in order to secure the reservation.

No deposits shall be refunded in the event of reservations.

If the visitor cancels due to death or other acceptable reason, a deposit may be return subject to supporting documents being submitted.

Visitors leaving prior to expiry of a reservation shall not receive any repayment for the balance of the in leaded stay.

This also applies to quest being evicted due to inappropriate behavior.

Payments of deposits must be made prior to arrival and or requested date in order to secure a reservation.

Should visitors not pay the deposit before the requested date, the reservation will not be confirmed.

The full balance due for the entire stay may be paid upon arrival. Payment in respect of additional vehicles or persons may be made upon arrival.

5. ARRIVALS AND DEPARTURE

Special arrangements with managements can be made for later departure. Prior agreement must be obtained.

6. REFUSAL TO CHECK IN / CANCELLATION

Deposits will not be re-paid in respect of cancellations.

In the event of campsite not being occupied within 24 hours of reserved date arrival, it shall be allocated to another guest, and will all payments made be forfeited.

7. INDEMNITY

Visitors enter the site and / or camp entirely at their own risk and will the owner and/or management not be held liable for any loss, injury or damage caused as a result of whatever nature.

The visitors indemnify the owner and/or it's representatives against any claims in this regard.

All equipment and facilities are used at own risk.

8. GENERAL RULES

The person responsible for making the reservation shall convey its contents to any of their guests and/or any person in their party who shall be deemed to have knowledge hereof and bound by this as if agreed to in writing.

8.1 Setting up camp are only allowed under the oak trees on the patches of ground, **NO PITCHING OF TENTS ARE ALLOWED ON GRASS** although our stands are usually grassy and lush, it is advisable that you bring ground sheets as stands do get worn with regular use. Failing to do so management will ask you to move your tent.

8.2 All contraventions must be reported to the management, as must any breakages or damage. Ensure all utensils and equipment are left in a good order. Breakages, missing items will be redeemed from the tenant.

8.3 FIRES ARE PROHIBITED DIRECTLY UNDER OAKTREES. NO FIRES ARE TO BE MADE ON GRASS OR GROUND, use Braai drum provided or braai put at Lapa. No fire may be left unattended, and must be extinguished before leaving the campsite or retiring to bed.

Under no circumstances may wood be collected or appropriated (trees chopped down) for firewood. Wood can, if required be purchased from management.

8.4 NO DAY VISITORS ALLOWED unless special arrangement with management

If Management allow guests to receive visitors subject to such visitors not being permitted to stay over in which event a day fee will be charged accordance to management.

8.5 NO MUSIC WILL BE ALLOWED TO BE PLAYED

IN CASE OF A GROUP BOOKING WILL MUSIC ONLY BE ALLOWED TO BE PLAYED IN THE LAPPA AREA UP TO 1H00 FOR 1 NIGHT ONLY. **PRIOR ARRANGEMENT WITH MANGEMENT MUST BE MADE ABOUT PLAYING OF MUSIC.**

8.6 Please keep all facilities clean and neat after use. No smoking is permitted in the ablution blocks. Children under the age of 10 years must be accompanied by an adult during use of ablution facilities

CHILDREN ARE NOT ALLOWED PLAYING IN ABLUSION FACILITIES, IN THE LAPPA OR POOL AREA.

8.7 No empty bottles, cans, containers or other refuse (cigarette butts) may be littered, and must be disposed of in container bins provided for this purpose;

8.8 **NO PETS ALLOWED** (remember this is a working farm)

8.9 Our trees are protected and may not be damaged; no picking of flowers or harvesting of plant material is permitted.

Be careful of snakes and please do not permit children to play in the bushes;

SWIMMING POOL:

8.10 No eating or drinking in swimming pool are allowed.

No glass bottle etc. is allowed in or around the pool area;

No braai at swimming pool area or preparing of food.

NO LILO'S, TUBES ARE ALLOWED IN POOL.SWIMMING POOL ARE ONLY THERE TO COOL OFF IN, WE ARE UNDER SEVERE WATER RISTRCTIONS AND DO NOT HAVE WATER TO FILL UP THE POOL.

SWIMMING POOL GATE MUST BE KEPT CLOSE AT ALL TIMES AND NO FIDDELING WITH SELF LOSING SPRING ON GATE.

NOBODY ARE ALLOWED TO CLIMB OVER SWIMMINGP POOLGATE OR WALLS OF THE SWIMMING POOL AREA.

POOL RULES displayed on pool gate no visitor shall violate any of these rules, management

reserve the right of access to any person who does not comply with the pool rules.

8.11 **Swimming pool may not be used after 20h30**

8.12 Please do not allow or provide employees and/or cleaners with alcoholic beverage during stay or at departure

8.13 Any unruly behavior or foul language will not be tolerated

8.14 Parents/Guardians, are at all times, responsible for supervision of children in their care.

THE FOLLOWING MUST BE OBSERVED:

No "Quad bikes", unlicensed vehicles may be used on the premises;

The use of Fire-arms, Pellet guns, Crossbows, Slings or Fireworks are not permitted

Climbing over fences, walls or gates are prohibited.
